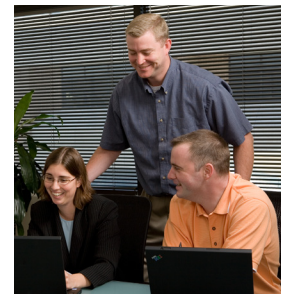

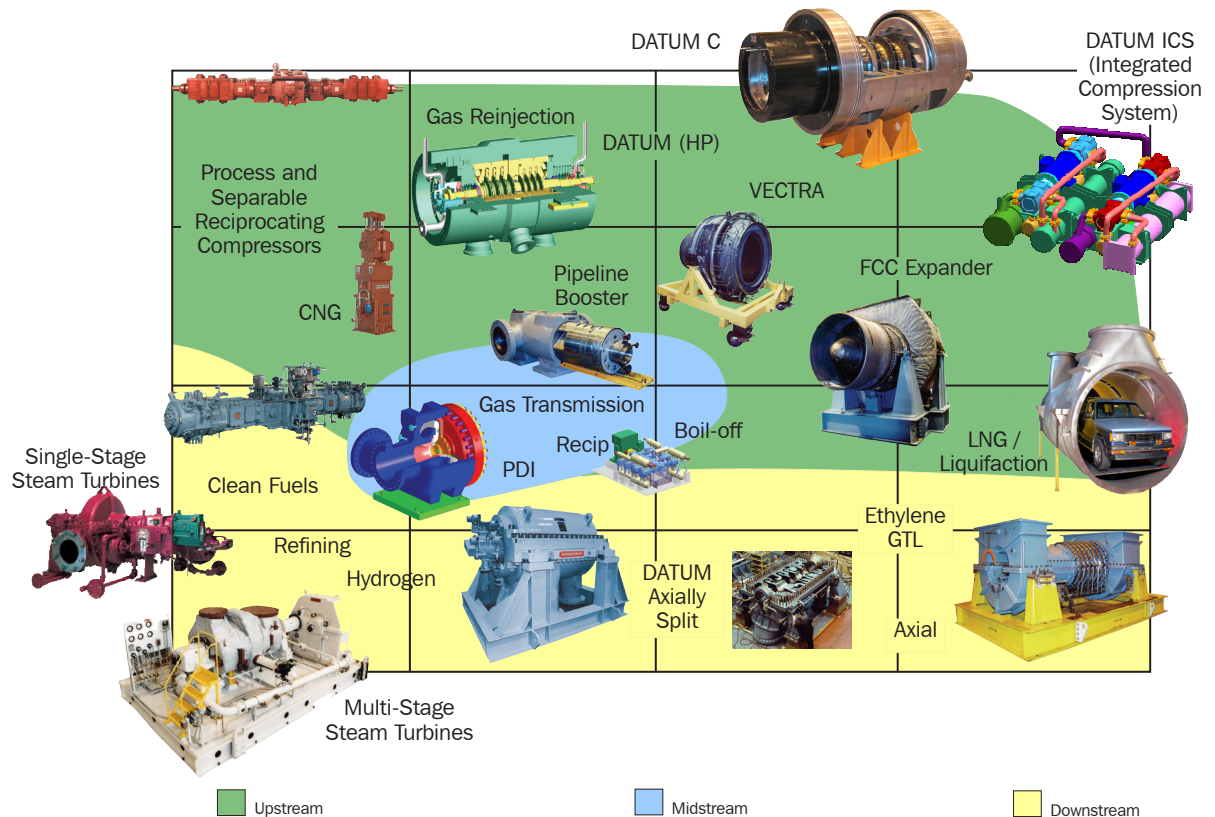

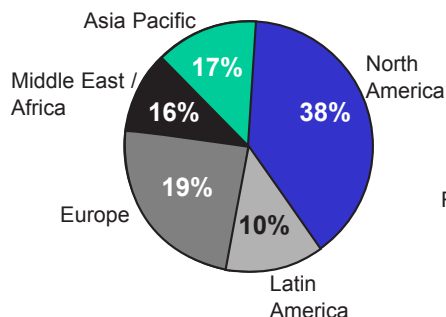

*Largest installed base*—Dresser-Rand built its first compressor more than a century ago and now has more than 94,000 rotating equipment units installed in more than 140 countries.

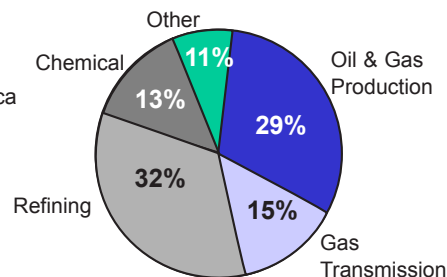
